COMMUNITY CREDIT FAIRS ARE PROVIDED WITHIN THE COMMUNITY, PROVIDING FICO CREDIT REPORTS, AS WELL AS PERSONALIZED ACTION PLANS, ALL WITHIN A 15-MINUTE ON-SITE MEETING. VOLUNTEERS HELP TO DELIVER CLASSES AND STAFF CREDIT FAIRS. CREDIT REVIEWS ARE ONE-TIME MEETINGS OFFERED TO CLIENTS WHO MAY NOT BE READY FOR IN-DEPTH COACHING BUT WANT TO START THEIR CREDIT-BUILDING JOURNEY. IN FISCAL YEAR 2021, THE ST.
