VOLUNTEERS HELP TO DELIVER CLASSES AND STAFF CREDIT FAIRS. CREDIT REVIEWS ARE ONE-TIME MEETINGS OFFERED TO CLIENTS WHO MAY NOT BE READY FOR IN-DEPTH COACHING BUT WANT TO START THEIR CREDIT-BUILDING JOURNEY.
